Nevada Rural Hospital Partners Foundation (NRHPF) held its 25th Annual Golf Tournament on Friday, September 22, 2023, at Washoe County Golf Course in Reno. Thanks to your participation, we had **107** golfers this year and raised over **\$34,000**. Our best year yet! These funds are used for educational programs for our member hospitals' staff.

Since 1996, NRHPF has worked to consider the common needs of the rural hospitals in Nevada, and to develop educational programs to meet those needs. One of the most important utilizations of funds generated through the golf tournament is the Human Resources Work Group (HRWG). This work group meets in person once a year, as well as via videoconference once a month, and provides vital educational offerings and the sharing of best practices for our rural HR Directors. NRHPF also supports the ability of other work groups to meet in person by supplementing limited grant funding.

Moreover, up to **\$2,000** a year can be used by each member hospital for the purpose of education and training, allowing members to choose the educational opportunities that best meet their individual needs.

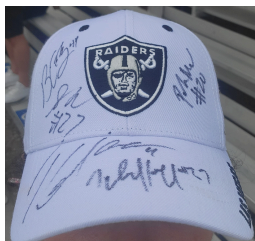
»»» RAFFLE WINNERS
